A RESOLUTION ADOPTING THE FY 2009-11 BUDGET, MAKING APPROPRIATIONS AND LEVYING TAXES.

WHEREAS, the City of Sandy has complied with State of Oregon Local Budget Law (ORS 294.395-.710) in preparing a proposed budget, conducting budget committee meetings resulting in an approved budget, causing to have published notice of public hearing and financial summary of the adopted budget, and holding a public hearing with regard to the budget; and

WHEREAS, the City of Sandy desires to adopt a budget for the coming biennial period (FY2009-11), make appropriations, and levy a property tax as required by ORS 294.326.

THEREFORE, BE IT RESOLVED, that the City Council for the City of Sandy adopts the budget for FY2009-11, as amended, in the sum of \$33,446,344;
