Presumptive Fines: The fine set by the state is on your citation.

Reduction: Your fine will be reduced if you have no moving violation convictions in the past three years.

Your fine will be reduced if your vehicle equipment is repaired or your violation is now remedied, such as your driver's license, insurance or vehicle registration.

Failure to Appear: A money judgment will be entered for the maximum fine if you fail to appear at a court proceeding.
