

## Downtown Parking Advisory Committee Regular Meeting Wednesday, April 18, 2012

- 3. New Business
  - a. Maps for Restricted Parking Committee members discussed the three maps that were presented by staff. The first map showed the proposed two hour on-street parking zone that would include Pioneer and Proctor Boulevard's from Meinig Avenue to Scales Avenue, and include Shelley Avenue between Pioneer and Proctor. The other two maps showed two options for the public parking lot in Block 18 between AEC and the Frontier Building. Option A for the lot was the option as recommended by DPAC at the March meeting. Option B for the lot was the revised staff option as recommended after visiting with several businesses within Block 18. There was some discussion regarding the benefits of both options, but staff recommended hearing from more businesses before deciding which option to forward for the parking open house meeting.
  - b. Parking District Town Hall Logistics Committee members discussed different date options for May and June, and discussed different times. Beth Scarth recommended the meeting be called an "Open House" which was unanimously agreed upon. The Downtown Two Hour Parking District Open House will occur on Wednesday May 30th from 6 PM to 8 PM. There will be light snacks and refreshments. Staff will get the word out via mail, email, the Sandy Post, Facebook, and the City website.

## 4. Old Business

a. Yellow Curbing – Mike Walker and Kelly O'Neill explained the analysis behind the yellow curb evaluation. This analysis included explanations why some areas were to be removed and why other areas were to remain. Some prominent areas will also be marked with signage as 'no parking'. Areas around hydrants and bus stops will have new yellow curb paint applied. Some areas around driveways will most likely need to be re-evaluated on a case by case basis. In addition, the no parking signs on Pleasant Avenue adjacent to the Sandy Elementary School and Middle School will be removed. Staff will complete notification to the school district about the change.

- b. Mail Drop Box Relocation Update Staff explained that the USPS Postmaster was very easy to work with and that the two mail drop boxes on Pioneer Boulevard would be moved to the new location just west of Scales on Friday April 20th. USPS posted the move information on the existing boxes and staff posted a sign at the new location. The new location will soon have a widened sidewalk to accommodate individuals with a handicap.
- c. One-on-One Block 18 Meetings David Snider and Kelly O'Neill explained the process behind the one-on-one meetings with business owners and property owners in Block 18 of downtown. The meetings were being held to introduce people to the two hour downtown parking district proposal and to obtain feedback regarding the changes in the public parking lot. Staff explained that the businesses have been very positive regarding the proposed two hour on-street parking district, but there has been some debate and concern regarding the apportionment of two hour versus no restriction spaces within the Block 18 public parking lot.
