5. DIRECTOR'S REPORT

Development Services Director O'Neill explained the Director's Report and answered questions regarding upcoming meetings and the report. 6. NEW BUSINESS

6.1. Leslie Pole Barn Variance (21-005 VAR)

Chairman Crosby opened the public hearing on File No. 21-005 VAR at 6:40 p.m. Crosby called for any abstentions, conflicts of interest, ex-parte contact, challenges to the jurisdiction of the Planning Commission, or any challenges to any individual member of the Planning Commission. No challenges were made, and no declarations were made by the Planning Commission.

Council Liaison Sheldon stated that June 7, 2021 would be a good meeting to mention in-person versus hybrid meetings. Chairman Crosby asked O'Neill for some additional information regarding June 7. O'Neill provided additional information as requested.
