“Peaceful Vistas” Mural Restoration Report 9-18-2019

The restoration of the “Peaceful Vistas” mural, by Roger Cooke, is finished. This was quite an undertaking, as so much of the original paint was lost. The entire mural was repainted, except for the artist's signature, which was left untouched.

The lead artists, Becky Hawley and Pamela Smithsted, chose to create a community project by including other local artists in the painting process. Arts Commissioner and Wy’east Artisans Guild President, Marcia Morrow spent an afternoon painting; WAG member, Micaiah Meyer spent a significant 45 hours on prep and painting, WAG member, Vern Groff spent two afternoons painting figures; Lori Putman, a Sandy Historical Society volunteer, spent about 8 hours painting and a recent Sandy High graduate, Taylor West, offered a couple of hours of her time. There was over 280 hours of volunteer labor spent on prep and paint, with Pam and Becky putting in over 220 volunteer hours. The process took over 3 weeks to complete.

Countless passersby shouted and honked encouragement and thanks for our efforts. A number of people stopped to visit and talk about the artist and the mural's history.

The restoration project finished under budget, due in large part to Ernie Brache, from AEC, who loaned the use of a scissor-lift for the duration of the project. John and Allison Milward, Ace Hardware, fulfilled their commitment to furnish Ace supplies and accommodate the volunteers, which was much appreciated.

But, we aren’t done yet...

In order to extend its life, the mural should have a preservation clear-coat and an anti-graffiti coat applied. Commissioners Hawley and Smithsted would like to commission a plaque containing the artist's information, the historical significance of the mural and the restoration information. Both of these items are unfunded at this time.

Materials used:

Gallon- Zinsser Peel Stop clear primer

Paintable caulk

Nova Paint-acrylic by Artex, all lightfastness 1 colors

Clarke+Kingston 100% acrylic-- white

Proposed for preservation: 2 gallons of Muralshield clear UV coating (2 or 3 coats) and 1 gallon World's Best Graffiti Barrier (2 coats) applied by a skilled person who would be approved by Milwards, the owners.

This application needs to be repeated every 7 to 10 years.

To prep for renewal: First remove the graffiti coat with a hot pressure wash. Touch up paint as needed, wait several days for the paint to cure and then apply new coats of Muralshield and graffiti coat.

**Graffiti should be removed with a hot pressure wash and a new barrier coat applied.
