Sandy Arts Commission...

The Sandy Arts Commission advises the City Council in the creation, development, and implementation of public art activities and programming to enrich the visual and aesthetic environment of the community. Public art builds up the community by celebrating local identity, enhancing the livability of the community, and providing a vehicle for economic development. With the establishment of an arts commission, the City of Sandy can begin the process of making strategic decisions about public art installations and events in the community, with residents having an opportunity to participate in the selection process.

Members shall be appointed upon the basis of demonstrated interest in, and knowledge and support of the arts. The City of Sandy encourages individuals from diverse backgrounds to apply. This includes residents, business owners,

Our Mission...

The mission of the Sandy Arts Commission is to increase the livability and economic value of our city, for both residents and visitors.

Serving as an advocate for the visual and performing arts; we promote art and cultural enrichment by facilitating increased opportunities for, access to, and enjoyment of, the arts.

The Basics....

Our current meetings are scheduled for the third Wednesday of the month, but this could change as the makeup of the commission changes. The attendance requirement is 75% of all meetings and events.

Commissioners are expected do work outside of the monthly meetings, as much of our work is handled by committees and then presented at meetings. Some of the current projects are listed below:

A year ago, we began an Art Inventory, which is a work in progress. The inventory revealed the fact that our murals were in serious need of restoration, so we undertook the challenge of finding a solution for each one.

The most degraded mural and therefore the most urgent, was the *Peaceful Vistas* pioneer mural on the east wall of the ACE Hardware, which was completely repainted last summer. We will hold a rededication of the mural in the spring. Currently, volunteers are working on the City Hall mural, by Robert Thomas, which is dry-rotted and in very rough condition. The work is being done indoors this fall and winter.

SAC put together a chalk art contest, "Only Rain Down The Drain" which was held in July, at the Sandy Library. We plan another chalk art event this summer.

We are on the lookout for public art opportunities and funding, which makes finding a grant writer very important. This winter we are seeking input from the community on their thoughts on public art for Sandy.

In short, we have no shortage of projects for SAC involvement, both as an official Sandy Arts Commission and/or, as a volunteer.
