#### 3.1. Covered Structures Phase II - Follow-Up Project Review

The **Economic Development Manager** summarized the staff report, which was included in the agenda packet. Slides were also presented, which are attached to these minutes.

The Board discussed the following Covered Structure grant applications:

### **Bigfoot Growlers**

Board discussion ensued on the following topics:

- The owner's long-term intentions for usage of the building
- Desirability of the proposed structure for possible future building tenants
- How the proposed structure relates to the existing awning structure
- Depth of the structure and how it could affect the estimated cost
- Whether the structure would tie back to the building
- Possible usage of ARPA funds
- Possible triggering of ADA requirements
- Whether the proposed structure makes sense given that the existing awning wraps around to the side of the building
- Whether the project would be more appropriate under the Facade Grant program

The consensus of the Board was that the project should be redesigned, usage of Facade Grant program as an alternative should be considered, and the Board will consider the matter at a future meeting.

#### Sandy Inn Best Western

Board discussion ensued on the following topics:

- Whether the structure would require impervious surface
- Whether the proposed placement of the structure is ideal
- Whether the proposal would be a prudent use of funds
  - Outlook for the business in the event of future shutdowns
  - Consistency of the application with the program's original intentions and the intentions of relief funds
