Staff Report

SUBJECT: Supplemental Budget BN 2019-21

BACKGROUND:

The Sandy Urban Renewal Agency adopts a biennial (two year) budget in June of odd number years. The current biennium's budget was adopted in June 2019. Due to length of time that our budget covers, it occasionally becomes evident that changes need to be made to the adopted budget. Local Budget Law allows for changes to be made to the budget after adoption in certain circumstances. Changes that are less than 10% of the total fund can be adopted at a regularly scheduled Board meeting. Changes that over 10% of the total fund require a public hearing. The following change is less than 10% of the total fund, therefore no public hearing is required.

It is anticipated that an additional \$25,000 will be needed to cover the cost of personnel. The current appropriation for personnel is \$247,200. Due to the implementation of the Pay Equity Study and Compensation Analysis in Summer 2020, personnel costs have increased within the Urban Renewal Fund. Staff recommends moving \$25,000 from contingency to personnel to avoid any expenditures over the budgeted appropriations. A summary of the changes is provided below:

A RESOLUTION ADOPTING A SUPPLEMENTAL BUDGET FOR THE SANDY URBAN RENEWAL AGENCY FOR BN 2019-21

Whereas, the City of Sandy has adopted a biennial budget for the period July 1, 2019 to June 30, 2021. Local Budget Law (ORS Chapter 294) allows for changes to the adopted budget via supplemental budget in certain cased; and

Whereas, ORS 294.473 allows the governing body to adopt a supplemental budget at a regularly scheduled Council meeting if the changes are less than 10% of the current adopted fund total; and

Whereas, the implementation of the Pay Equity Study and Compensation Analysis in 2020 has increased the anticipated expenditures related to Personnel Services making it necessary to reallocate Contingency to Personnel Services.

NOW, THEREFORE, BE IT RESOLVED by the Board of the Sandy Urban Renewal Agency that the following budget be amended as follows:
